

ADDENDUM TO DOT POLICY - JANUARY 2018

DRUG AND ALCOHOL TESTING PROCEDURES

Effective January 1, 2018 the following regulations have been updated: 49 CFR Part 40.

APPLICABILITY – The updated regulations apply to transportation employers and safety-sensitive employees, contractors and volunteers regulated by the Department of Transportation.

PART 40 DRUG TESTING PANEL CHANGES

The United States Department of Transportation (USDOT) – Office of Drug and Alcohol Policy and Compliance (ODAPC) has issued an update to USDOT’s drug and alcohol testing regulation (49 CFR Part 40). The new regulation has been revised and the changes (summarized below) will become effective on January 1, 2018. Therefore, this drug and alcohol testing policy is amended as follows:

- a. Four new opioids have been added to the drug testing panel –
 - i. The list of opioids which are tested for during a USDOT drug test will expand from three to seven opioids.
 - ii. The “opioid” category will continue to test for codeine, morphine, and heroin; however, the “opioid” testing panel will now be expanded to include four (4) new semi-synthetic opioids:
 1. Hydrocodone
 2. Hydromorphone
 3. Oxycodone
 4. Oxymorphone
- b. ‘MDA’ will be tested as an initial test analyte
- c. ‘MDEA’ will no longer be tested for under the “amphetamines” category

UPDATED DOT DRUG TESTING PANEL

Effective January 1, 2018, all USDOT regulated tests will be tested using the following testing panel:
